

Notice is hereby given that pursuant to Resolution Nos. 16-04 and 16-06 of the Board of Education of Fostoria City School District, Ohio, adopted on May 16, 2016, and June 27, 2016, respectively, there will be submitted to a vote of the electors of said School District at an election to be held in said School District at the regular places of voting therein, on Tuesday, November 8, 2016, the question of renewing all of an existing tax levy in the sum of One Million Six Hundred Eighty-Seven Thousand Three Hundred Twenty-Seven Dollars (\$1,687,327) per year for a period of 10 years for the purpose of providing for the emergency requirements of the School District. If a majority of the voters voting thereon vote in favor thereof, that tax will commence in 2017, and be first due in calendar year 2018.

The estimated tax outside of the ten-mill limitation necessary to raise that annual amount as certified by the County Auditor is 8.1 mills for each one dollar of valuation, which amounts to 81 cents for each one hundred dollars of valuation.

The polls for said election will be open at 6:30 a.m. and will remain open until 7:30 p.m. of said day.

Notice is hereby given that in pursuance of resolutions of the Board of Education of the Tiffin City School District, Seneca County, Ohio, adopted on July 26, 2016 and August 2, 2016, respectively, there will be submitted to the electors of the Tiffin City School District at an election to be held in that School District at the regular places of voting therein on Tuesday, November 8, 2016, the question of the renewing all of an existing 1.0-mill tax levy and increasing that levy by 1.72 mills to constitute a tax in excess of the ten-mill limitation for the benefit of the Tiffin City School District for the purpose of general permanent improvements at a rate not exceeding 2.72 mills for each one dollar of valuation, which amounts to 27.2 cents for each one hundred dollars of valuation, for a continuing period of time. If a majority of the voters voting thereon vote in favor thereof, that levy will be first placed on the tax list and duplicate in December 2017 for first collection in calendar year 2018.

The polls for the election will be open at 6:30 o'clock, a.m., and will remain open until 7:30 o'clock, p.m., of said day.
